

# REGISTRATION

## TERMS AND CONDITIONS

### 1. General

1.1 SAFRA Diaper Dash 2025 ("Event") is organised by SAFRA National Service Association ("Organiser") in accordance with these Rules & Regulations ("Terms") that is applicable to the Participants, which can be found at [www.safra.sg/diaperdash2025](http://www.safra.sg/diaperdash2025) ("Official Website").

1.2 Please read these Terms carefully before submission of online registration form. Completion and submission of the online registration form confirms your agreement to abide by the Terms of the Event.

1.3 By registering for the Event, you confirm that:

(a) you consent to SAFRA's collection, use and disclosure of your personal data and your child's personal data for the purposes of registration and managing SAFRA Diaper Dash including but not limited to contacting you via email and short message service (SMS) on the Event for purposes of administering your registration, and for other applicable purposes as set out in SAFRA's Privacy Policy (<https://www.safra.sg/privacy-policy>), as amended from time to time, which outlines how SAFRA manages your personal data in accordance with the Personal Data Protection Act 2012;

(b) where Personal Data of any third party is provided by you, you have obtained the consent of the third party to SAFRA's collection, use and/or disclosure of those Personal Data.

(c) you are solely responsible for the personal data that you provide or disseminate, notwithstanding that the dissemination is via third party platforms, including but not limited to SAFRA's Facebook page, and your personal data may also be subject to the personal data policies of such third party platforms.

1.4 The Organiser may disclose Registration Data without notice, only if required to do so by law or in the good faith belief that such disclosure is deemed necessary to the Organiser.

1.5 All reasonable efforts are made by the Organiser to ensure that any Registration Data held by the Organiser is stored in a secure and safe place.

1.6 Photographs, videos and other recordings ("Media") including your child will be taken by the Organiser at this event. By attending this event, whether as a participant, staff or volunteer, you consent to and grant the Organiser the right to use such Media for internal records purposes, publicity purposes, commercial advertising and distribution to its sponsors and partners.

1.7 Please note that non-official photographers might also operate at this event. SAFRA has no control over and is not responsible in any way for any Media produced by non-official photographers.

## 2. Registration

2.1 The Organiser has the absolute discretion to reject and refuse the registration of a potential participant without assigning any reason to the participant, and to terminate such registration for any reason whatsoever.

2.2 The Organiser reserves the right to cancel or postpone the Event at any time. The Organiser may but is not obliged to notify the Participants of such cancellation or postponement. If the Event has to be cancelled or postponed, there shall be no refund of registration fees paid, and the Organiser shall not be liable for any other loss or inconvenience caused.

2.3 The Organiser reserves the right to set the fees for the different categories as expedient to its intents and purposes.

2.4 Once the online registration form has been processed, there will be no refund of registration fees for those Participants who eventually do not take part in the Event, for whatever reason.

2.5 Registration will not be accepted after the closing date of 16 May 2025, 2359hrs.

2.6 Upon successful registration, you are not allowed to change the category that you have registered for.

2.7 All category registrations are non-transferable and non-refundable.

2.8 The Organiser reserves the right to close registration before the official closing date should participation reach its capacity.

2.9 The Organiser will not be responsible for any dispute arising from incomplete or incorrect information submitted by Participants.

2.10 Completion of the online registration form evidences the Participant's agreement to abide by the Terms and Conditions of SAFRA Diaper Dash 2025.

2.11 The Organiser reserves the right to limit and refuse registrations/entries without assigning any reasons thereof.

2.12 The Organiser reserves the right to replace the race pack items with items of similar value.

2.13 For any registrations using SAFRAPOINTS, please email a copy of your receipt to **events@safra.sg** for verification and confirmation.

### 3. Race Requirements

3.1 The Organiser reserves the right to amend the requirements of the Event as they deem fit for the safety of the Participants and/or to prevent any potential hazards in the running of the Event, at any time without prior notice to the Participant. In such cases, every effort will be made to inform the Participant prior to the date of the event. The Organiser shall not be liable for any other loss or inconvenience caused due to such changes.

### 4. Medical Safety

4.1 Whilst reasonable precautions will be taken by the Organiser to ensure the safety of Participants, Participants take part at their own risks and the Organiser, their sponsors and their appointed officials shall not be liable for any death or injury, loss or damage, suffered or otherwise, and howsoever arising.

4.2 The Organiser reserves the right to remove any Participant deemed physically incapable of continuing with the Event to prevent him/her from causing greater harm and injury to himself/herself.

## INDEMNITY

1. I fully understand and acknowledge the risks involved in my participation in SAFRA Diaper Dash 2025 and I accept full responsibility and assume all such risks.
2. I hereby represent, warrant and undertake to the Organisers the following with full knowledge that they shall be relied upon by the Organisers in accepting my registration:
3. My personal particulars and my child's particulars disclosed in the registration form are accurate, full and complete.
4. My child does not have any medical condition that would affect my child's safety or physical well-being.
5. My child is medically and physically fit and competent to participate in SAFRA Diaper Dash.
6. I shall dutifully and fully abide by these Rules & Regulations and any applicable laws.
7. I confirm that the representations, warranties and undertakings herein are and will continue to be true and accurate.
8. I (including my heirs, successors and assigns) undertake not to make any claims or lodge any complaints whatsoever against the Organisers, any of their affiliates, any sponsors and/or officials of SAFRA Diaper Dash 2025 for any injury, death or loss/damage to property sustained during the Event/disputes over any matter in relation to the Event.
9. I (including my heirs, successors and assigns) agree to hold the Organisers, their affiliates, sponsors, appointed officials/suppliers (each an 'Indemnified Party') harmless and keep each Indemnified Party fully and effectively indemnified from and against any

and all losses, costs (including legal costs on a full indemnity basis), claims, damage and expenses whatsoever which any of them may incur (directly or indirectly) as a result of my breach of any of these Rules & Regulations.

10. These Rules & Regulations shall be governed under Singapore laws and I agree to submit to the exclusive jurisdiction of the Singapore courts.
11. I agree to allow the Organisers or their contractor(s) to contact me for any purpose connected with or arising from SAFRA Diaper Dash 2025.
